

**DEWEY'S PIZZA FREE PIZZA FOR A YEAR SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER TO WIN

SWEEPSTAKES DESCRIPTION: The Dewey's Pizza Free Pizza for a Year Sweepstakes (the "**Sweepstakes**") begins on Monday, February 9 at 11:00 a.m. ET and ends on Saturday, February 28 at 10:00 p.m. CT (the "**Sweepstakes Period**"). Entry in the Sweepstakes does not constitute entry into any other promotion or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of AED Enterprises, LLC, 3061 Madison Road, Cincinnati, Ohio 45209 (the "**Sponsor**" and "**Promoter**"), which shall be final and binding in all respects.

ELIGIBILITY: Open only to legal U.S. residents who reside in Kentucky, Kansas, Missouri, Illinois, or Ohio (collectively, the "**Territory**") who are eighteen (18) years of age or older at time of entry. All entry information submitted becomes the sole property of Sponsor.

WINNER SELECTION AND NOTIFICATION: On or about Monday, March 9, one (1) Grand Prize, one (1) Second Prize and one (1) Third Prize winner will be randomly selected by representatives of Sponsor from among the eligible entries received during the Sweepstakes Period. The potential prize winner(s) will be notified via email. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason.
